## **VI. ITEMS OF BUSINESS**

### **A. PUBLIC HEARING**

**OR 22-022** An Ordinance Appropriating Monies From The Central Treasury For The Borough Operating Funds, Enterprise Funds, Education Operating Fund And Capital Funds, Establishing The Rate Of Levy For All Borough Functions For The Fiscal Year Beginning July 1, 2022, And Ending June 30, 2023; And Setting The Surcharge Rate For The Wireline And Wireless Enhanced 911 Systems For The Period Of July 1, 2022, Through June 30, 2023.

Assemblymember Bernier spoke to the spring yard work he has been doing.

Assemblymember Hale apologized for missing the last public hearing. Advised that he was at the Glacier View Community Council meeting speaking to the amendment to the apportionment legislation that moved them into Assembly District 7.

Assemblymember McKee advised that she has been in Fairbanks and apologized for missing the last public hearing.

Assemblymember Tew apologized for missing the last budget meeting. Noted that he will be in attendance from this day forward.

Assemblymember Sumner commented on the low public participation at the budget public hearings. Stated that he is looking forward to budget amendments that may come. Opined that generally speaking, the Manager put forward a reasonable budget that may only require a bit of fine-tuning.
