SUMMARY STATEMENT: Pursuant to Matanuska-Susitna Borough (MSB) code, 3.08-170(F), the following is a summary of Bid Solicitation 23-091B, Brett Memorial Ice Arena Roof Replacement.

The MSB entered into a contract with H5 Construction, LLC, on June 28, 2023, for Bid Solicitation 23-091B, Brett Memorial Ice Arena Page 1 of 2

Roof Replacement. The original contract amount of \$ 579,333.38 was approved through Assembly Action, AM 23-059, presented on June 20, 2023. Funding was provided by Ice Rink & Pools - Replacement, Repairs, & Improvements, fund 15053-1000-1001 and Brett Memorial Roof Replacement, fund 15053-5500-5501.
