Amendment No. 3 Areawide Fund - Nondepartmental (page 60) and Capital Projects (page 488)

Assemblymember Hale moved a primary amendment and any conforming changes as follows:

- \* the areawide fund, non-departmental, transfer to 415/425/430/435/440/470 (445.220) by increasing the appropriation by the amount of \$250,000;
- \* adding the capital project Pioneer Peak Trailhead Expansion for the amount of \$250,000; and
- \* the following project description: Austin Helmers Trailhead. This project would expand the existing limited parking area and install a concrete vaulted toilet system at the trailhead. Currently, the existing parking is approximately 1/10th of an acre, and vehicles park on the narrow shoulder of the roadway, creating a safety hazard. The proposed improvements would expand the trailhead facilities to nearly 1 acre. There is currently a substandard outhouse at the trailhead that does not meet environmental regulations and is in a state of disrepair.
