SUMMARY STATEMENT: On April 19, 2022, the Matanuska-Susitna Borough Purchasing Division issued a solicitation requesting bids from qualified contractors to supply labor, materials, equipment, and supplies to construct approximately 4,805 linear feet of shared use pathway along Nelson Road. The project will extend the existing Nelson Road Pathway from Machetanz Elementary. This project will involve, but is not limited to, clearing, grubbing, 1,700 cubic yards of Unclassified Excavation, 2,200 tons of Selected Material, Type A, 1,100 tons of Aggregate Base Course, Grading D-1, and installing drainage culverts. Additional items include topsoil and seeding. As an additive alternate, the pathway would include paving 540 tons of Hot Mix Asphalt, Type II; Class B and installing

detectable warning tiles. Construction Services purchased will support the Public Works Department in assembly district #3.

In response to the advertisement, one bid was received. Award recommendation is being made to Granite Construction as the lowest responsive and responsible bidder based on Total Bid Amount.

The substantial completion date for this project is August 16, 2022 with the final completion of December 16, 2022.

In accordance with MSB  $3.08.170\,(\mathrm{B})$ , Administration requests authority to modify the resulting contract completion date by 30 days for unforeseen circumstances.

The Public Works Department, Operations & Maintenance Division will be administering the contract with the aid of HDL Engineering who will be performing construction administration services.

## BID 22-142B Nelson Road Pathway

#### **SCOPE OF WORK**

#### <u>General</u>

This project's purpose is to construct approximately 4,805 linear feet of Nelson Road Pathway. The project area is located adjacent to Nelson Road approximately 3 miles west of the Glenn Highway in Wasilla, Alaska. See project location and vicinity maps.

All construction shall be completed in accordance with the Alaska Department of Transportation and Public Facilities (ADOT&PF) Standard Specifications for Highway Construction (SSHC) 2017 Edition. Project specific special provisions are provided in the following sections. The requirements contained in these specifications and special provisions are hereby made a part of this solicitation and resultant contract.

Contractor is to provide resources to complete this project without any adjustments in the original bid amount or contract time.

Contractor shall coordinate the road improvements with all utility relocation work. Request locates from the utilities having facilities in the area. Use the Alaska Digline, Inc. Locate Call Center. See Section 105-1.06 for digline number and a list of utility companies in the area.

Work Zone speed limit: Limit speed of vehicles associated with the construction to 20 mph within project limits.

Contractor shall complete ROW and utility easement staking and clearing for utility relocation support upon NTP. This work shall be included in items 201(3B), 642(1), and 641(3). Additional stump removal for utility support will be directed if needed and is not included in these items. The anticipated additional utility support areas are as follows:

- STA 20+00 to 20+50
- STA 22+75 to 23+50
- STA 24+50 to 25+50
- STA 54+00 to 55+00

Normal work time will be between 7 a.m. and 7 p.m. Extensions will be considered and approved by the MSB inspector.

Time is of the essence. Work shall be completed in one continuous timeframe after utility relocations are completed. Substantial completion is August 16, 2022 and Final completion is December 16, 2022.

Estimated project magnitude for the Base Bid work is less than \$150,000.
