SUMMARY STATEMENT: Pursuant to Matanuska-Susitna Borough (MSB) Code, 3.08-170(F), the following is a summary of Bid No. 23-084B to Dirtworks, Inc., for the Doc McKinley and Jessie Jo Place Road

Improvements Project.

The MSB entered into a contract with Dirtworks, Inc., on April 28, 2023, for Bid No. 23-084B, for Doc McKinley and Jessie Jo Place Road Improvements Project No. 30046-6600-6694. The original contract amount of \$1,098,965.50 was approved through Assembly Action AM No.23-043 presented on May 16, 2023.

There were no change orders required for this contract. Prior to closure, unit quantities were adjusted to actual, which reduced the contract amount by \$137,680.74 resulting in a final contract amount of \$961,284.76.
