Opined that nothing that was discussed in the last planning session has been accomplished. Related that he had expressed to Mr. Brown that he would like more documentation and noted that he delivered on that request.

Assemblymember Boeve thanked the advisory boards in her district. Opined that the Assembly should continue to value the input of all advisory boards. Noted that she cannot do her job without their input. Thanked all those that serve on advisory boards.

Mayor Halter thanked Mr. Brown for the report on school funding. Noted that the Shirley Towne bridge needs replaced as it was damaged in the September 2012 flood event.
