Budget Deliberations and Possible Adoption

I. CALL TO ORDER

The special meeting of the Matanuska-Susitna Borough Assembly was held on Tuesday, May 9, 2024, at the Borough Assembly Chambers, 350 E. Dahlia Avenue, Palmer, Alaska. The meeting was called to order at 6:01 p.m. by Mayor Edna DeVries.

II. ROLL CALL

III. APPROVAL OF AGENDA

The agenda was approved as presented without objection.

VI. ITEMS OF BUSINESS

A. BUDGET DELIBERATIONS AND POSSIBLE ADOPTION

OR 24-024 An Ordinance Appropriating Monies From The Central Treasury For The Borough Operating Funds, Enterprise Funds, Education Operating Fund And Capital Funds, Establishing The Rate Of Levy For All Borough Functions For The Fiscal Year Beginning July 1, 2024, And Ending June 30, 2025; And Setting The Surcharge Rate For The Wireline And Wireless Enhanced 911 Systems For The Period Of July 1, 2024, Through June 30, 2025.

Ms. McKechnie noted that the Assembly has until 5:00 p.m. Wednesday, May 10, 2024, for submit a reconsideration for the budget. If no reconsideration is received the May 14, 2024 Assembly Special Meeting Re: Budget Deliberations and Possible Adoption will be cancelled.

Assemblymember Yundt spoke to the Mat-Su Health Foundation. Stated that he would be providing maps of unmaintained roads within the borough for the body to review.

Assemblymember Gamble noted concern for the Matanuska-Susitna School District's budget process.

Assemblymember Fonov noted he has concerns with the Matanuska-Susitna School District's budget process.
