SUMMARY STATEMENT:

On June 21, 2016, Ordinance 16-085 was approved by the Assembly authorizing the issuance of areawide general obligation bonds of the borough, in one or more series, in the aggregate principal amount of not to exceed \$22,160,000, to finance the cost, in whole or in part, of such parks and recreational capital facilities and related capital improvements, and for providing for the submission to the voters of the borough a proposition ratifying the

authorization of such bonds on October 4, 2016.

On October 4, 2016 voters did ratify the authorization of such bonds and the Bond 2017 Series A was issued for projects that included the Nine Trails Projects and the Big Lake Area Trail Bridges.

The original scope of work for the Nine Trail Projects included nine (9) trails to be reconstructed, improved and/or relocated including the Ridge Trail, Wasilla Creek Headwaters Trail, Menard Sports Complex Trail System, Plumley-Maud, Matanuska Riverfront Trail South, Matanuska Riverfront Trail North, Brasil Springs to Crevasse Moraine, the Haessler-Norris Trail System, and the Herning Trail.

Pre-Design and Engineering (PD&E) Division would like to consolidate the remaining funding from the Nine Trail Projects into a new project, the Trail Bridge Improvements Project which will include any needed reconstruction or major improvements identified for all bridges constructed within the bond package. Inspections to determine the needs for reconstruction or major improvement will be done through areawide parks and recreation funding. Only those bridges needing reconstruction or major improvement will be funded through this project. Things such as painting, sealing, cleaning and the like are not major improvements and will also be funded through areawide parks and recreation funds.

The Trail Bridge Improvements Project will also be used to carry out any needed reconstruction or major improvements for the Groomer Gully Bridge on the Iron Dog Trail and the bridge over Fish Creek also on the Iron Dog Trail. These bridges were part of the Bond 2017 Series A, as the Big Lake Area Trail Bridges, a standalone project not part of the Nine Trail Projects, but part of the same parks and recreation bond package. The construction of these bridges is completed.

The trail bridges constructed as part of the bond package are used by the public and the Borough, as a responsible manager, should carry out regular inspections and be aware of any repairs or improvements needed. It is PD&E's intent to carry out biannual trail bridge inspections through the use of funding within the areawide parks and recreation budget and fund any reconstruction or major improvement from the Trail Bridge Improvements project. The inspections will identify any needed improvements on the bridges developed by the aforementioned bond package.

Project No. 15043, Wasilla Creek Headwaters Trail, Haessler-Norris, Herning, and Mat River Fron South have funds available in the amount of \$75,560.92.
