A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY APPROVING THE AMENDED SCOPE OF WORK TO INCLUDE ALL CONSTRUCTION, EQUIPMENT AND REQUIRED COMPONENTS TO PROJECT NO. 25048-2400-2414 AND THE AMENDED BUDGETS FOR PROJECT NOS. 25048-2400-2414, 25048-2400-2416, AND 25048-2400-2417.

WHEREAS, in the fiscal year 2020 Capital Projects budget, \$70,000 was appropriated for project no. 25048-2400-2416 for the purchase of a Skid Steer; and

WHEREAS, the skid steer was purchased using FY19 budget funds and there remains \$68,850 in funding available; and

WHEREAS, in the fiscal year 2020 Capital Projects budget, \$75,000 was appropriated for project no. 25048-2400-2417 for the purchase of universal waste collection replacement facilities; and

WHEREAS, that project is not moving forward in the near future and there remains \$75,000 in funding available; and

WHEREAS, in the fiscal year 2020 Capital Projects budget, \$500,000 was appropriated for project no. 25048-2400-2414 for the fire suppression and ventilation repair/upgrades in order to comply with State of Alaska regulatory guidelines; and

WHEREAS, further funding is required to fully fund the fire suppression and ventilation repair/upgrades project engineers estimate.

NOW, THEREFORE BE IT RESOLVED, that the Assembly hereby approves the following amended scope of work for project no. 25048-2414 and the amended budgets for project nos. 25048-2414, 25048-2416, and 25048-2417.

25048-2400-2414 AMENDED SCOPE OF WORK

Design, permitting, construction, equipment and all components to facilitate repairs and a functional upgrade and addition to the fire suppression and ventilation system at the Hazardous Waste Facility/ Administrative Office Building at the Central Landfill.
