Assemblymember Tew thanked everyone that participated in the meeting. Thanked Mr. Ortiz for his presentation.

Mr. Brown stated that the Assembly provided clear direction on wanting enforcement on residents that push private snow that is pushed into the right-of-way. Advised that letters have been sent to a number of violators. Spoke to the process of how enforcement and citations would occur. Noted that staff is actively working on it.

Ms. McKechnie spoke to her surprise on how quickly hand count numbers were called in. Stated that there are two canvass boards now, so that all the kinks could be worked out before next year's election.

Assemblymember Fonov spoke to his pleasure of working with Deputy Manager Hays. Spoke to how easy it has been and how much he has learned. Spoke to the need to keep doing what is working so far as junk and trash removal proceeds. Noted that labor is the most expensive cost for cleaning up neighborhoods.

Assemblymember Yundt spoke to the cost of tabulating machines that the Borough used to use for elections. Opined that it's less expensive to have humans hand count ballots. Complimented Ms. McKechnie and her office for a job well done. Summarized the cost of the recent free dump days to assist in community cleanup. Spoke to a possible way for Code Compliance to address properties that are chronically a problem.
