SUMMARY STATEMENT: On April 14, 2022, the Matanuska-Susitna Borough Purchasing Division issued a solicitation requesting bids from qualified contractors to perform annual road maintenance for Road Service Area (RSA) #16, South Colony. Contractor will furnish all labor, materials, supervision, equipment, transportation and supplies for the maintenance of this RSA. Services purchased will support the Public Works Department in assembly districts 1, 2 & 6.

In response to the advertisement, three bids were received. Award recommendation is being made to McKenna Bros. Paving, Inc. as the lowest responsive and responsible bidder based on Total Bid Amount.
