MATANUSKA-SUSITNA BOROUGH ORDINANCE SERIAL NO. 22-007

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY APPROPRIATING \$8,000,000 FROM AREAWIDE FUND BALANCE TO THE ROADS AND BRIDGES CAPITAL PROJECTS FUND TO BEGIN WORK ON PROJECTS APPROVED BY BOROUGH VOTERS ON NOVEMBER 2, 2021.

WHEREAS, the intent, rationale and supporting information for this ordinance is found in Informational Memorandum No. 22-009, Informational Memorandum No. 21-155, Ordinance Serial No. 21-076 and Resolution Serial No. 22-002.

BE IT ENACTED:

Section 1. <u>Classification</u>. This ordinance is a noncode ordinance.

Section 2. Appropriation Source. There is hereby appropriated \$8,000,000 from Areawide Fund Balance, 100.272.000 to Roads and Bridges Capital Project, fund 430. The Borough shall determine the application of available money between the various Projects in an order and manner deemed most necessary and advisable by the Borough.

Section 3. <u>Purpose</u>. Paying the cost, in whole or in part, of all necessary planning, acquisition of property for, site preparation, construction, installing, and equipping of the <u>Projects</u>, architectural, engineering, design, and other consulting

services, inspection, testing, and administrative expenses. This applies to any one or more of the following projects effective December 1, 2021:
