**TITLE**

Matanuska-Susitna Borough School District Deferred Maintenance - Fiscal Year 2026

**SCOPE OF WORK**

This project provides deferred maintenance funding to assess, plan, design, repair, rehabilitate, and replace aging or failing building systems and infrastructure within Matanuska-Susitna Borough School District facilities. Work may include evaluation and improvement of mechanical, electrical, plumbing, structural, envelope, and other building systems approaching the end of their service life or experiencing operational deficiencies. Services may include engineering assessments, preparation of design and construction documents, cost estimating, and support during

procurement and construction, as well as the repair, replacement, or upgrade of deteriorated or obsolete systems necessary to maintain safe, reliable, and efficient facility operations.
