## MATANUSKA-SUSITNA BOROUGH ORDINANCE SERIAL NO. 18-100

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ACCEPTING AND APPROPRIATING \$143,500 FROM THE ALASKA STATE DEPARTMENT OF MILITARY AND VETERAN'S AFFAIRS, EMERGENCY MANAGEMENT PERFORMANCE GRANT PROGRAM, AND REQUESTING A REAPPROPRIATION OF \$143,500 FROM THE EMERGENCY MANAGEMENT FISCAL YEAR 2019 OPERATING BUDGET, TO FUND 425, PROJECT NO. 45285, FOR EMERGENCY MANAGEMENT WAGES AND BENEFITS.

WHEREAS, the Borough has received a grant from the Alaska State Department of Military and Veteran's Affairs for emergency management wages and benefits; and

WHEREAS, the Borough is required to provide matching funds in the amount of \$143,500 in order to comply with the conditions of the grant and to receive the grant; and

WHEREAS, the Assembly must accept and appropriate the \$143,500 from the Alaska State Department of Military and Veteran's Affairs prior to the expenditure of said funds; and

WHEREAS, no expenditures can be made until the scope of work and budget have been approved by the Assembly; and

WHEREAS, the scope of work and budget are contained in Resolution Serial No. 18-069; and

WHEREAS, the acceptance and appropriation of the grant funds serves a public interest.

BE IT ENACTED:

Section 1. <u>Classification</u>. This ordinance is a noncode ordinance.

Section 2. Acceptance and Reappropriation Source. The Assembly hereby accepts a grant in the amount of \$143,500 from the Alaska State Department of Military and Veteran's Affairs, Emergency Management Performance Grant Program, and reappropriates the amount of \$143,500 from the Emergency Management Fiscal Year 2019 Operating Budget, to fund 425, project no. 45285 for Emergency Management wages and benefits for the period of July 1, 2018, through June 30, 2019.

Section 3.  $\underline{\text{Effective date}}$ . This ordinance shall take effect upon adoption.
