SUMMARY STATEMENT: On July 14, 2020, in AM No. 20-065, the Assembly awarded Bid No. 21-001B to Northstar Excavation & Asphalt, Inc. for the Landfill Gas Collection & Control System Construction, for the contract amount of \$1,911,229.00.

In AM No. 20-65, the substantial completion date #1 of October 30, 2020 was required for all work except the flare and skid installation, start-up and testing. All work is now substantially complete, but the portion that is described as excepted.

The originally approved substantial completion date #2 for all remaining flare and skid work is January 15, 2021 with a final completion date for this project as August 15, 2021.

This request is for approval to extend the substantial completion date #2. Flare delivery is now projected to occur before February 26, 2021 with installation and start-up occurring afterwards. This extension request is due to the delay in delivery of the manufactured flare from the subcontractor, Perennial Energy who is located in Missouri, to Northstar Excavation & Asphalt, Inc., the project contractor here in Alaska. The delay is due to extended lead times for source material suppliers to Perennial Energy.
