

2025 State Legislature Intent Language in DPS Operating Budget

 It is the intent of the legislature to direct public safety funds to areas of the state that do not have the tax base to provide needed policing services to their communities. The Department of Public Safety executives are urged to meet with officials from three organized, nonunified boroughs in the state, Kenai Peninsula, Fairbanks North Star and Matanuska-Susitna, who do not currently offer adequate local public safety services and encourage them to take the steps necessary to police their respective boroughs rather than relying on the State to provide those services. The Department shall submit a full response to the Co-chairs of the Finance committees and to the Legislative Finance Division by December 20, 2025, outlining the communication, feedback, or actions taken by each borough.

Alaska State Troopers

- Wasilla Police Department
 - 28 sworn officers, 31 authorized positions, 7 non-sworn personnel
 - Calls: 2024 24,428 / 2025 to date: 14,375
- Palmer Police Department
 - 17 sworn officers, 17 authorized positions, 11 non-sworn personnel
 - Calls: 2024 10,014 / 2025 to date: 5,626
- Five School Resource Officers: Colony and Palmer (PPD); Houston, Redington, and Wasilla (WPD); District covers 75% of the cost; Sixth officer planned for CTHS/TMS

Department of Public Safety (DPS)

Current Status


- 7 leases in MSB
- \$600,000 \$700,000 annually
- Trooper Posts owned in other boroughs

Opportunity

- The intent is to develop a space for DPS entities currently operating in the MSB to be housed together (ABI, AST, AWT, SDEU, Admin Staff) with consideration for other units
- Space between 35,000 40,000 sq. ft., which includes large spaces for garage, training rooms, etc., as well as outside storage

Station 6-5 / 5-2

MSB is looking to consolidate Station 6-5 at Seward-Meridian / Palmer-Wasilla Hwy and Station 5-2 at Bogard / Engstrom into one facility



Regional Dispatch (E911)

Proposal:

- Upgrade both MATCOM and 9GBase to a common, agreed-upon architecture
- Develop shared decision-making (governance) including AST, MSB, Palmer, and Wasilla that provides regional benefit and resiliency
- Integrate personnel, technology, and infrastructure to enhance public safety response capabilities, reduce service duplication, and improve coordination across municipal boundaries

- Currently, two independent centers
 - MATCOM (Wasilla): Call-taking and dispatch for AST, WPD, and all regional fire and rescue (contracts with MSB and DPS)
 - 9GBase (Palmer): Dispatch for PPD
- Efforts to modernize infrastructure are already underway

Areawide Animal Care Services

NEW PROPOSAL:

- Consolidate to areawide enforcement to all 3 cities
- Estimated 850+ additional cases/year (Palmer: 200+, Wasilla: 550+, Houston: 100+)
- Increases budget by 1 FTE officer and equipment ~\$300,000 annually
- Recurring budget impact to areawide:

 .24 mills; net decrease to those outside cities of .049 (\$19.02 average) and increase to city residents of .24 (\$93.14 average)
- Benefits: Consistent enforcement, reduced jurisdictional issues, improved public safety and animal welfare

CURRENTLY:

- Each city currently enforces its own animal care and control code
- 2,000+ annual cases in borough
- Most enforcement in cities handled by:
 - Palmer: Palmer Police Department
 - Wasilla: Code Compliance Officer (day), Wasilla PD (after hours)
 - Houston: Public Safety Director
- Staff: 1 Chief Officer, 4 Officers, 1 1000hour Officer, 1 Dispatcher
