SUMMARY STATEMENT: On October 17, 2019 the Matanuska-Susitna Borough Historical Preservation Commission received a request from the State of Alaska Office of History and Archaeology to review a nomination for the National Register of Historic Places, located within the Borough. The nomination is for High Ridge, a property associated with Fred and Sara Machetanz. The Commission was tasked with reviewing the nomination materials and making a determination on the eligibility of the property for listing in the Register.

The Commission met on December 5, 2019 to discuss and act on the review request. It was determined that this project supports many of the Borough's historic preservation interests as outlined in MSB 4.46, Historical Preservation Code, and that this project will help protect our area's cultural resources. The Commission unanimously approved HPC Resolution 19-02, attached, in support of the High Ridge National Register of Historic Places nomination.
