B. Discussion Regarding the Use of Schools as Election Precinct Locations and the Possibility of Closing Schools on Election Day (Requested by Assemblymember Yundt)

Ms. McKechine advised that it was Assemblymember Yundt who requested this agenda item. Noted a constituent called him with concerns about adults being in schools as the same time as children on Election Day. Related that Assemblymember Yundt proposed that Election Day could be scheduled as an in-service day for teachers. Noted that teachers would work, but students would not be there. Stated that the Alaska State Division of Elections has requested no school on election day next year.
