In the event there is a future question or debate about the Manager's power under this ordinance, this supplement to the Informational Memorandum is intended to clarify the intent of the legislation.

Existing Borough Code MSB 8.05.090 provides that only the Matanuska-Susitna Borough Assembly can waive landfill fees. Ordinance Serial No. 19-006 proposes to amend Matanuska-Susitna Borough Code to allow the Borough Manager to waive or reduce charges for the transfer and disposal of solid waste in the event of a declared local disaster. The proposed ordinance is not a requirement that fees be waived, but rather grants the Borough Manager the authority to do so.

The Borough Manager's power to waive or reduce fees will only be in effect in the event of a local declared disaster. Under AS 26.23.140, such a declaration is limited in time:

"A local disaster emergency may be declared only by the principal executive officer of a political subdivision. It may not be continued or renewed for a period in excess of seven days,

except by or with the consent of the governing board of the political subdivision . . .

As a practical matter, any need to extend a local disaster declaration beyond a seven day period would need Assembly approval. If there is ever a need to extend a fee waiver authorized by the Borough Manager, it can be done by the Assembly at the same time.

CONCLUSION

The result of the analysis above, and the intent of Ordinance Serial No. 19-006 is that the Borough Manager's power to waive or reduce landfill fees is limited to the same duration of time as power to declare a local disaster emergency. It can only be done for a period of seven days and any further extension requires Assembly approval.''
