SUMMARY STATEMENT: The Public Works fund 480, project no. 20266, scissor lift and trailer project were part of the fiscal year 2026 approved budget. The projected expenses for this project are under budget resulting in excess funds. Operations and Maintenance would like to reappropriate \$12,000 to fund 435, project no. 10063 to modify an existing door to become ADA compliant at DSJ.
