SUMMARY STATEMENT:

This resolution is sponsored by Assemblymember Sumner to direct the Borough Manager in the preparation of future budgets that include a Fuel Excise Tax.

The intent of this tax is to create a revenue source to forward fund voter approved capital projects without incurring debt requiring an increase to the Areawide mill rate. There is also a desire to utilize the fuel excise tax to reduce the Areawide mill rate and shift the taxes proportionally to the 16 Road Service Areas

(RSAs) so that there is available revenue to fund capital projects specifically within the RSAs. This would result in the overall taxes for property owners remaining the same.

The attached resolution directs the Borough Manager to reduce the Areawide mill rate by the millage equivalent of 30% of the budgeted fuel excise tax when preparing the areawide budget.

A voter approved transportation capital project will be budgeted for in an amount equivalent to 70% of the budgeted fuel tax revenues.

Finally, the RSA mill rates will be increased proportionally by the total amount of the areawide tax reduction. For example, if there is \$5,000,000 budgeted in Areawide fuel excise tax the amount of the Areawide mill rate reduction total would be \$1,500,000. Using the fiscal year 2026 1 mill equivalent this would be a reduction of 0.101 mills. That \$1,500,000 would be allocated proportionally to the RSAs to increase their mill rates.
