SUMMARY STATEMENT: On January 16, 2024, the Assembly approved the Road Improvement List - 2024 which included the Birch Harbor Estates Project. The Birch Harbor Estates Improvement project includes South Goose Bay Drive, South Tradewinds Circle, West Snug Harbor Avenue, South Birch Cove Circle, and South Cook Inlet Circle, located within Road Service Area 17 Knik. The Project Number is 30040 (22-17-4711).

As part of the design process, utilities review the project design to determine if there are conflicts with their utilities. If conflicts cannot be resolved, utility relocation is required before construction.

Matanuska Telecom Association, Inc. (MTA) has planned upgrades in this subdivision. In working with the MSB, MTA has agreed to advance relocations beyond the permitting requirements. An estimate was received from MTA for the MSB Birch Harbor Estates Project forced relocation in the amount of \$283,613.05. MTA has proposed a 50% discount for a fixed cost of \$141,806.53 to expedite the relocations to meet their timeline.

The Administration requests approval for utility relocation costs of \$141,806.53 for the Birch Harbor Estates Improvement Road Improvement project.

RECOMMENDATION OF ADMINISTRATION: Approve utility relocation costs of \$141,806.53 to MTA for the Birch Harbor Estates Road Improvement Project.
