VIII. MAYOR, ASSEMBLY, AND STAFF COMMENT

Assemblymember Hale opined that the body did a good job on the budget. Spoke in support of funds for road bond projects. Stated that he is glad that they body reduced the mill rate by 10.74 percent. Noted that he is glad the budget was adopted before his birthday.

Assemblymember Bernier thanked the body for the meeting.

Lonnie McKechnie, Borough Clerk, handed out election brochure to the Assembly. Requested that if they have any changes to please let her know by May 17. Requested to keep the May 12, budget deliberation meeting as scheduled even though the budget is adopted. Advised that if there are no reconsiderations by 5 p.m. on May 11, that she would cancel the meeting.

Mayor DeVries queried if there was any objection.

There was no objection noted.

Assemblymember Yundt stated that he was happy to see Dr. Trani in attendance this evening. Stated that he was not trying to surprise anyone with amendment no. 8 and noted that he voted against his own amendment because he wanted to show that he is not trying to hide anything. Opined that the budget process is a great one and that members have brought thoughtful amendments forward. Spoke to how amendment no. 8 moved funds around in the budget, the result, and the reserve that remains for the School District. Noted that the funds from amendment no. 8 would only be targeted at projects that would benefit the School District. Related that he spoke with two School Board Members and advised them of his proposed amendment. Stated that he intended to meet with Dr. Trani on Thursday to discuss it further.

Assemblymember Nowers thanked the body for their hard work on the budget. Thanked the Manager and the Finance Director for putting together a budget that would have been acceptable without any amendments. Spoke to her appreciation that the amendments were mostly aligned with the Assembly priorities. Opined that the Assembly needs to have a healthy reserve in order to cushion quick growth.

Assemblymember Sumner agreed that the budget was great to begin with but that the Assembly made some positive changes. Noted that it has been the smoothest budget cycle he has been involved with since he was elected. Noted that there is always the possibility of reconsideration if a member feels that something needs to be changed. Stated that he is pleased to see some of the road bond projects funded and able to move forward.
