SUMMARY STATEMENT: Borough administration intends to sign a grant amendment to extend the State Forestry funding to pay for wages, expenses, and equipment to extend the work season of the Borough Saw Crew. The no-cost amendment will provide an additional year and expire July 1, 2026. The Borough Assembly adopted Ordinance Serial No. 24-032 on February 20, 2024, accepting and appropriating \$400,000 from the Alaska Department of Natural Resources, Division of Forestry for the Saw Crew Project. The accompanying grant agreement expires June 30, 2025. The grant amendment would extend the expiration date to June 30, 2026.

The crew was hired in November 2021 and has focused on cutting shaded fuel breaks and felling hazard trees on borough-owned land. The saw crew has also been constructing firebreaks and performing fuel reductions on borough property with dense stands of beetle-kill spruce in residential areas.

Saw crew has prioritized their work on Borough-owned properties with high concentrations of beetle-kill spruce and hazard trees, in close proximity to populated areas, and high levels of public use.

The crew has completed work at the Mat-Su Career and Tech High School, Butte Elementary, and Meadow Lakes Elementary. The crew recently began work at Su Valley High School. The crew has also been conducting fuel reduction work at Alcantra Sports Complex, Crevasse Moraine Trail System, Matanuska River Park, Jim Creek Recreation Area and Lazy Mountain Recreation Area.

As project employees, the saw crew will continue to work until the project funding has been expended.
