SUMMARY STATEMENT: The 2022 Windstorm Disaster has expenditures that FEMA and the State of Alaska will not cover under the disaster and must be covered by the Borough. Currently the shortfall exceeds \$500,000 and there are additional claims in excess of \$350,000 that are still pending a final determination.

The American Rescue Plan funding includes revenue recovery funding in the amount of \$486,648.07 that is obligated to borough services, past legislation accepted and appropriated \$461,648.07 into the 2022 Windstorm Disaster project to offset a portion of those shortfalls, which due to staff error left \$25,000.00 in revenue recovery. This legislation will correct that error and move the remaining \$25,000.00 into the 2022 Windstorm Disaster project. Any remaining shortfall will be covered by the reallocation of insurance proceeds.
