XII. MAYOR, ASSEMBLY, AND STAFF COMMENTS

Assemblymember Tew thanked the body for the meeting. Spoke to his appreciation of Assemblymember Nowers comments regarding more funding for the community clean up program. Stated that he is hopeful that the body can reach a good resolution regarding the sand and chips issue that saves money.

Assemblymember Bernier spoke in support of the sand and chip issue being resolved.

Assemblymember Yundt opined that it was a busy meeting with a lot of good discussion regarding the land fill. Reminded the body that the Assembly directed staff to go in the direction that they did with sand and chips. Stated that he would personally work with staff to bring forward better information and be clear about benefits to the public. Spoke to his support of the second amendment.

Assemblymember Nowers spoke in support of the sand and chips being produced at the landfill. Stated that she believes it provides an overall savings. Noted that she understands that some members need more information before they can make a decision and that she is supportive of that. Stated that she wanted to respond to a comment about the election made by a member of the public regarding using paper ballots. Queried if it is true that the Borough does use paper ballots and that there is nothing that connects to the internet so it is impossible to compromise the election via the internet.

Ms. McKechnie affirmed the query.

Assemblymember Nowers invited anyone with questions about the election to volunteer as an election official to learn the process. Stated that she is looking forward to a larger discussion regarding junk and trash, which has been a long running problem. Spoke to her service on the Susitna Basin Recreation Rivers Advisory Board. Noted that the State is looking to adopt a management plan for six rivers in the Borough to balance user interests and that they are requesting public input prior to making revisions.

Assemblymember Sumner spoke in support of postponing the sand and chips legislation in order to receive more information. Stated that the more it was discussed, the less he understood. Noted that the need to ensure that it is an actual savings to residents. Thanked the body for the meeting.

Mayor DeVries thanked the Department of Emergency Services for the hard work and quick responses to emergencies over the Memorial Day weekend.
