#### VIII. MAYOR, ASSEMBLY, PLANNING COMMISSION, AND STAFF COMMENT

Planning Commission Member Chesbro thanked staff for the presentaions this evening as they were very informative.

Planning Commission Member Vague thanked staff for all the hardwork put into the presentations.

Assemblymember Sykes spoke in support of a possible "anchor tenant" at Port MacKenzie. Spoke to conern with the lease and the contract for the timber sale at the Port. Opined that the Assembly should have a work session on the legislation.

Assemblymember Sykes moved to schedule a work session on Ordinance Serial Nos. 18-017 and 18-018, on April 3, 2018, at 2 p.m. The motion passed by the following vote:

Assemblymember Sykes thanked staff for presentations and thanked the body for the meeting.

Assemblymember Kowalke spoke to his long history of working on the proposed timber sale contract and lease. Spoke to concerns that any attempt to generate revenue at the Port is constantly met with opposition.

Assemblymember Mayfield spoke in support of the proposed timber sale and the revenue it will generate, which will make the Port profitable. Noted the project has been worked on for a very long time. Opined that members have known that this project was coming forward for a very long time as it did not occur in a vacuum. Opined that if there is a project that will provide relief to the tax payers and improve the economy, that the Assembly would be guilty of a breach of trust if they did not move it forward. Thanked staff and the Planning Commission. Stated that it was a great meeting and that he learned a lot.

Assemblymember Beck moved to have the Planning Department and the Law Department conduct a comprehensive review on code compliance violations and enforcement and to refer the info that is gathered to the Planning Commission for 90 days from today to provide recommendations to the Assembly to include staffing, costs, any code changes, and the stronger ability to enforce the code. The motion passed by the following vote:

Yes: 7 - Assemblymember Sykes, Assemblymember Beck, Assemblymember McKee, Assemblymember Leonard, Assemblymember Mayfield, Assemblymember Doty, and Assemblymember Kowalke

Assemblymember Doty noted that it is important for the Assembly to all be on the same page so that they will know why the lease and timber contract did not go out for competitive bid. Stated that she enjoyed the Transportation Advisory Board report and would like to have more of them.

Assemblymember Leonard spoke in support of the April 3, 2018, work session. Stated that he would like to see a flow chart of how this lease and contract have come to fruition in order to understand the history of its development. Thanked staff for the presentations.

Assemblymember Beck thanked the public for their testimony. Thanked staff for their knowledge, skills, and hard work. Stated that he is thankful to be on the Assembly.

Mayor Halter opined that it was a great joint meeting. Noted that tomorrow is Assembly member Doty's birthday and wished her happy birthday.
