SUMMARY STATEMENT:

Public Works identified four bridge projects that need funding or additional funding. Funding is available for these projects in the Bridge and Railroad Crossing Major Maintenance and Repair, Fund 410, project number 35000, in the Hidden Hills Road Railroad Crossing Signal project, Fund 410, project number 30038, and in the 2024 Sushana Drive at Little Susitna River Flooding Mitigation, Fund 410, project number 30048.

The Michelle Drive Bridge at Willow Creek Erosion Mitigation, Fund 410, project number 30042, requires \$450,000 for installing armoring of the streambank.

The Lewis Loop Bridge at Fish Creek, Fund 410, project number 30040, requires \$252,000 to upgrade the bridge superstructure and abutments.

The King Salmon Drive Bridge at Cottonwood Creek, Fund 410, project number 30045, requires \$100,000 for preliminary design.

The Bradley Road Bridge Replacement over Trapper Creek, Fund 410, project number 30050 requires \$675,000 for construction. The Assembly previously adopted Resolution Serial number 23-005 approving \$1,090,179.71 for design and construction for the Bradley Road Bridge Replacement.

The Areawide Budget Appropriation and Fund Balance Appropriation for the 2024 Sushana Drive at Little Susitna River Flooding Mitigation is set to expire 6/30/2026. Public Works requests the expiration date of the funding be extended to 6/30/2029 to account for the Federal Emergency Management Agency (FEMA) grant award and construction timeframe.

RECOMMENDATION OF ADMINISTRATION: Approve the scopes of work and the budgets for the Michelle Drive Bridge at Willow Creek Erosion Mitigation project, the Lewis Loop Bridge at Fish Creek project, and the King Salmon Drive Bridge at Cottonwood Creek project; and approve the amended budgets for the Bridge And Railroad Crossing Major Maintenance And Repair project, the Hidden Hills Road Railroad Crossing Signal project, the 2024 Sushana Drive At Little Susitna River Flooding Mitigation, and the Bradley Road Bridge Replacement over Trapper Creek project; and approve a time extension of the Areawide Budget Appropriation and Fund Balance Appropriation for the 2024 Sushana Drive at Little Susitna River Flooding Mitigation to June 30, 2029.
