Recommendation from the West Lakes Fire Service Area Board of supervisors

**SUMMARY STATEMENT:** This legislation is being sponsored by Assemblymember Gamble to annex six parcels into the West Lakes Fire Service Area.

The Borough received a petition to annex six parcels on West Susitna Parkway into the West Lakes FSA. The petition met the requirements of the Borough code, by containing the signatures of

83.3 percent of the real property owners in the proposed area and was certified by the Clerk.

A.S. 29.35.450(c) and MSB 5.20.005(G)(1) allows for the annexation of properties into a fire service without placing the question of the annexation on the ballot if the result in increasing the number of parcels of land is not more than six percent and would not add more than 1,000 residents. According to the best available assessment data, this annexation would be adding six parcels to the existing 11,326 parcels and would increase the number of residents by 10.

The West Lakes FSA Board of Supervisors is in support of annexing the six parcels.

- 1. The description of this code change is shown in the ordinance.
- 2. The total number of parcels to be annexed is six.
- 3. The estimated cost of the proposed services is 1.946 mills per \$100,000 of assessed value as adopted by the Assembly for the FY26 budget.
- 4. The map of the proposed area for annexation into the fire service area is attached to this IM.

The property owners within the proposed area were notified when the legislation would be introduced and up for public hearing. They were also advised on how they can participate in the meeting.
