VII. MAYOR, ASSEMBLY, AND STAFF COMMENT

Mr. Spiropoulos provided an update on tax assessment appeals recently considered by the Board of Equalization and noted that the tax rolls were to be confirmed by the May 1 deadline.

Ms. McKechnie spoke to a scheduling conflict for the June 3 tentative budget deliberation meeting.

Mayor Halter queried if there was any objection to changing the time of the meeting from 6 p.m. to 2 p.m. on Monday, June 3.

There was no objection noted and the meeting was rescheduled.

Mr. Moosey commended Mr. Brad Pickett, Borough Assessor, on the department's efforts to fairly assess and tax the property owners after the earthquake disaster. He also announced that the Popular Annual Financial Report was available on the Borough's website.

Assemblymember Leonard thanked the audience for their testimony on the budget. He urged the Assembly to reconsider the scheduled budget deliberation meetings for May 13 and 14, as the state of Alaska budget was not scheduled to be adopted until May 15.

Assemblymember Sykes spoke in favor of moving the budget deliberation meetings closer to the June 4 date. He thanked the public for its testimony on the School District funding and encouraged the public to contact their state legislators to urge full funding for education. He spoke to the budget process and explained the effect on the community.

Assemblymember McKee spoke to the budget process, the involvement of the Assembly, and that of the community members in relation to funding the budget.

Assemblymember Boeve addressed a public member's comments opposing the efforts of the Assembly to engage the public by holding budget public hearings in locations outside of the Palmer area. She encouraged the Assembly members when traveling to the budget public hearing in Willow on May 2 to observe the devastating effects the spruce beetles have had on the spruce trees along the Parks Highway.

Assemblymember Mayfield thanked all attendees for their participation and attendance at the meeting. He spoke to consequences of the state budget cuts in relation to local governments.

Assemblymember Beck applauded the administration, teachers, and staff of the School District for their efforts to educate. He thanked the young persons who testified during the meeting and commended them on stepping up now to make a difference for the future. He praised the testimony on tourism.

Mayor Halter spoke to and clarified his memo to the Assembly regarding the school debt reimbursement. He noted another memo would be issued at a future date regarding the budget.
