SUMMARY STATEMENT: The West Lakes Fire Service Area has a requirement for a new fire apparatus.

MSB 3.08.360 allows the borough to enter into procurement agreements when it is in the best interest of the borough. Sourcewell, formally known as National Joint Powers Alliance (NJPA), solicits, evaluates and awards contracts through a national competitive solicitation process on behalf of its members. Members can choose these contracts and procurement processes which satisfy borough solicitation requirements and avoid duplication of the process.

A cost proposal was requested, received and deemed acceptable from General Fire Apparatus/Rosenbauer. The award recommendation is

Page 1 of 2 AM No. 24-137 being made based upon applying the chassis pre-pay option in the cost proposal. Exercising this option saves \$22,259.

Delivery of the apparatus is expected within 690 days upon contract execution.

The new Rescue Engine will be replacing Engine 73, a 1995 International Laverne. This will be an upgrade because engine 73 does not meet current safety standards such as an ABS braking system or load stability system. The Laverne does not have foam capabilities and is not built to current industry and DOT standards, or the NFPA 1901 Standard for Automotive Fire Apparatus.

This vehicle will be built to current industry, DOT and NFPA 1901 standards and will help meet NFPA 1911, 1500 standards. It will have a compressed air foam system (CAFS) for better firefighting capabilities as well as safe driving systems that will include stability systems, airbags, clean cab (hygiene air filtration) system and will be both mechanically and safety systems upgraded. This will enhance the community fire rescue emergency response.

The West Lakes Fire Service Area is located in Assembly District #5.
