## MATANUSKA-SUSITNA BOROUGH ORDINANCE SERIAL NO. 20-081

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ACCEPTING AND APPROPRIATING \$754,435 FROM THE ALASKA STATE DEPARTMENT OF MILITARY AND VETERANS AFFAIRS, DIVISION OF HOMELAND SECURITY AND MANAGEMENT EMERGENCY PUBLIC ASSISTANCE GRANT **PROGRAM** REIMBURSEMENT OF COST SHARE PAID BY  $\mathtt{THE}$ BOROUGH TO ALASKA DEPARTMENT OF TRANSPORTATION FOR REPAIRS TO EARTHQUAKE DAMAGED ROADS AND BRIDGES.

WHEREAS, in February of 2020, the Assembly authorized the Manager to execute an agreement with the Alaska State Department of Transportation and Public Facilities to repair earthquake damaged roads and bridges; and

WHEREAS, the repairs are scheduled using Federal Highway Administration funds that required a 9.03 percent match; and

WHEREAS, in February 2020, the Borough processed the 9.03 percent match in the amount of \$754,435 from the 2018 November Cook Inlet Earthquake repairs project, project no. 55027; and

WHEREAS, the Borough has received a grant agreement from the Alaska State Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management in the amount of \$754,435 for Federal Highway Administration cost share; and

WHEREAS, the Assembly must accept and appropriate these funds and authorize the Manager to sign the grant agreement prior to expending these funds.

BE IT ENACTED:

Section 1. <u>Classification</u>. This Ordinance is a noncode ordinance.

Section 2. Acceptance and Appropriation Source. The Assembly hereby accepts and appropriates grant funds of \$734,435 from the Alaska State Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management, Public Assistance Grant program for reimbursement to fund 445, 2018 Cook Inlet Earthquake repairs project, project no. 55027 for 9.03 percent cost share of Federal Highway Administration earthquake repairs.

Section 3. <u>Effective Date</u>. This ordinance shall take effect upon adoption.
