Ms. McKechnie noted that Assemblymembers Beck and Sykes have been on the Assembly for half of her career. Noted that she has enjoyed listening to Assemblymember Beck and Ms. Henry's occasional banter. Stated that both members will be missed. Thanked them for their service to the community.

Assemblymember Sumner noted that the last year has gone by quick. Spoke to his appreciation of having served with Assemblymembers Sykes and Beck. Stated that he intends to request the newly elected Assembly Members be included in the executive session tomorrow.

Assemblymember Leonard stated that he hoped that the Assembly understands how critical it is to work with Alaska Industrial Development and Export Authority (AIDEA) in opening up the west Susitna area. Noted that memorandums of agreement are critical for moving into public/private partnerships. Spoke to having attended a recent AIDEA meeting at which Mr. Moosey did a great job in presenting the importance of opening up that land for development. Related that he has worked in municipal government for about 20 years and that he has never seen more dedicated and hardworking people than Assemblymember Sykes and Beck. Noted that it has been his privilege to work with them. Commented that it is hard work and that they never shied away from it. Noted that Assemblymember Sykes put in an overabundance of time. Opined that Assemblymember Beck genuinely cares about his constituents. Spoke to his appreciation of being seated next to him at the dais. Stated that he has appreciated Assemblymember Beck's assistance with his mic button.

Assemblymember McKee stated that he is going to miss Assemblymembers Sykes and Beck. Noted that they have not always agreed,

Thanked Assemblymember Beck for his service. Related that she met him five years ago and that her respect for him grows with each interaction. Stated that Assemblymember Sykes' attention to detail and tireless service to his community is priceless. Thanked them for their friendship and support. Commented that they will be missed.

Assemblymember Mayfield noted that he learned a lot from Assemblymember Sykes and Beck during his first year. Opined that any words he could say to describe their service to the Borough would be inadequate. Thanked them for their service, friendship, and leadership. Noted that they are both compassionate people. Noted that Assemblymember Beck is a true gentleman and that Assemblymember Sykes attention to detail is unmatched.

Assemblymember Sykes spoke to his appreciation of all the kind words that have been said. Opined that Mr. Spiropoulos is a phenomenal municipal attorney who is smart and always prepared. Noted that Ms. McKechnie runs a tight ship who works hard to ensure a fair electoral process. Thanked Ms. Henry for her quick response to his many requests and commented on how efficient she is. Stated that Mr. Moosey is an asset to the Borough and a good choice. Noted that when he was first elected, that he made an effort to meet as many Borough employees as possible in order to see how things worked. Suggested that Assembly members speak to as many employees as needed to get the information required to make informed decisions. Stated that employees are dedicated and understand that they are there to serve the public. Noted that Assemblymember Sumner's construction experience post-earthquake was invaluable. Stated that he has known Assemblymember Leonard's wife for a long time. Spoke in appreciation of his financial experience. Noted that Assemblymember Boeve has been involved in her community for a very long time and that she dedicates quite a bit of time caring for her community. Thank her for her continued service. Stated that when he first met Assemblymember McKee he wondered who this cantankerous person was. Stated that he finds him to be very thoughtful with a lot of life experience and a great sense of humor. Advised him to keep his mind open. Noted that he and Assemblymember Mayfield met as candidates. Related that the Pt. MacKenzie Community Council had not had an assembly member at their meetings in a long time, so he had adopted

Noted that he is hard to persuade, but that if you have a good argument then it might be possible to sway him. Opined that he is a good mayor who is respectful and has a great sense of humor. Opined that it has been a terrific experience being on the Assembly. Noted that it is better to work together to make things happen, as single-minded agendas are no good. Spoke to the need for more public outreach. Noted that he is not a fan of social media, but folks do get their information there more now than ever. Noted how easy it is to spread information that is not accurate. Spoke to the need to be proactive and give residents information that is accurate. Noted that folks do not trust the government and that it has to be earned. Spoke to the positive growth in the Borough. Stated that he has enjoyed his work the last six years. Thanked everyone for their hard work and the public for participating in meetings.

Assemblymember Beck stated that he is humbled by all the kind comments. Stated that he is grateful to be a small part of something so great. Noted that being a part of the assembly has been incredible and that he has enjoyed the robust debates. Stated that his overall experience has been positive. Related that when he was first elected, that his brother had advised him that as an elected official, people will say and feel things about him that are not friendly, but to let it go. Spoke to the joy in his heart for his time on the Assembly. Stated that he has never met anyone who loves Borough more than Mr. Moosey. Related that when he went to see him in the hospital, he was working on Borough business. Noted that he was very dedicated. Thanked the Mayor for the opportunity to be deputy mayor. happy to have done it and enjoyed it. Spoke to his appreciation of sitting next to Ms. Henry at the dais and that at times it felt as though they were the old men in the balcony on the Muppet Show. Thanked the body for the positive working relationship over the years.

Mayor Halter spoke to his appreciation of the hard work of Assemblymembers Sykes and Beck. Noted that they both brought a lot to the Assembly. Opined that the newly elected officials have big shoes to fill, as they have been extremely dedicated and worked hard for their constituents. Noted that it is always good to have a diverse Assembly. Wished them well in their future endeavors.
