**SUMMARY STATEMENT:** The Operations & Maintenance Division requests the authorization to utilize Talkeetna Sewer & Water (TSW) Fund Balance, Fund 293, to pay off loan debt with the Alaska Department of Environmental Conservation (ADEC).

The TSW Utility was required to upgrade the Talkeetna Water System to address arsenic in the drinking water supply that exceeds the maximum contaminant level set by the Environmental Protection Agency. Debt was incurred as the TSW did not have the capacity to pay for the upgrades from their operating budget or from fund

balance at that time (OR 10-012, RS 10-003). In 2010, a low-interest loan was issued by the ADEC via the American Recovery and Reinvestment Act of 2009 as an eligible project under the Alaska Drinking Water Fund Program. Upgrades were completed in 2012, and the first loan payment was paid in 2013.

Fund 293 now has adequate fund balance to pay off the remaining debt balance of \$40,353.38 which will save \$2,457.24 in finance charges and eliminate 7 years of administrative management on the loan.
