

SUMMARY STATEMENT: On March 29, 2022, the Matanuska-Susitna Borough Purchasing Division issued a solicitation requesting bids from qualified contractors to realign, upgrade and improve the drainage along 1825 linear feet of North Lombardo Drive. This project will involve, but is not limited to, clearing, grubbing, excavation, import and placement of borrow material, import and placement of aggregate base and surface courses, placing hot mix asphalt, installing drainage culverts, and placing topsoil and seed. Construction Services purchased will support the Public Works Department in assembly district #1.

In response to the advertisement, four bids were received. Award

recommendation is being made to Dirtworks, Inc. as the lowest responsive and responsible bidder based on Total Bid Amount.

The substantial completion date for this project is September 30, 2022 with the final completion of December 16, 2022.

In accordance with MSB 3.08.170(B), Administration requests authority to modify the resulting contract completion date by 30 days for unforeseen circumstances.

The Public Works Department, Division Name Division will be administering the contract.



LOMBARDO DRIVE - ROAD IMPROVEMENTS
SCOPE OF WORK

General

This project's purpose is to realign, upgrade and improve the drainage along 1825 linear feet of North Lombardo Drive. This project will involve, but is not limited to, clearing, grubbing, excavation, import and placement of borrow material, import and placement of aggregate base and surface courses, placing hot mix asphalt, installing drainage culverts, and placing topsoil and seed.

All construction shall be completed in accordance with the Alaska Department of Transportation and Public Facilities (DOT&PF) Standard Specifications for Highway Construction (SSHC) 2017 Edition. Project specific special provisions are provided in the following sections. The requirements contained in these specifications and special provisions are hereby made a part of this solicitation and resultant contract.

- This project is located in the vicinity of North Old Glenn Highway, Milepost 16. The project may be accessed by proceeding onto N Eugene Dr., and E Harter Dr. See project location and vicinity maps.
- Contractor is to provide resources to complete this project without any adjustments in the original bid amount or contract time.
- Contractor shall coordinate the road improvements with all utility clearing and relocation work. Others will perform utility clearing and relocation. Utility clearing is anticipated to be completed by June 1st, 2022. Utility relocation will be completed as soon as possible once utility clearing is complete.
- Request locates from the utilities having facilities in the area. Use the Alaska Digline, Inc. Locate Call Center. See Section 105-1.06 for digline number and a list of utility companies in the area.
- Work Zone speed limit: Limit speed of vehicles associated with construction to 20 miles per hour within project limits.
- Time is of the essence. Work shall be completed in one continuous timeframe after utility relocations are completed. Substantial completion shall be achieved by September 30th, 2022. Final completion shall be achieved by December 16th, 2022.
- Normal work time will be between 7 a.m. and 7 p.m. Extensions will be considered and approved by the MSB inspector.
- Estimated project magnitude is less than \$295,000.
