SUMMARY STATEMENT:

On July 20, 2021 the Assembly adopted Ordinance Serial No. 21-058 creating North Suzanna Street Natural Gas Local Improvement District. The construction has been completed by Enstar Natural Gas and this ordinance is now before the Assembly to finance the improvements.

Ordinance Serial No. 22-032 confirms the assessment roll and Ordinance Serial No. 22-033 authorizes the financing for North Suzanna Street Local Improvement District No. 625 as required by MSB 3.28.080 and MSB 3.28.120. Both ordinances are necessary to complete the process for this local improvement district.
