SUMMARY STATEMENT:

The Matanuska-Susitna Borough Fiscal Year 2020 annual budget included \$500,000 in a capital project account for State and Federal Transportation Grant Match funding. The grant application this funding was intended to match, did not result in a grant award and is available for another use.

In November 2021, the Assembly approved a list of infrastructure projects for completion if funding was located. The Transportation System Projects list included the Caswell Lakes Road/Bendapole Road/Passthebait Avenue paving project.

The Federal Infrastructure bill has added significant funding to hundreds of grant programs that the borough is eligible to apply for, to provide funding to full transportation project list, once

the grant application period is opened. While the federal grant applications are pending for the remaining projects, this funding can be put to use on the Caswell Lakes Road/Bendapole Road/Passthebait Avenue paving project.

Before the funding can be used, it must be moved from the grant match account into the transportation project account and the scope of work and budget for the funds must be approved.
