# XII. MAYOR, ASSEMBLY, AND STAFF COMMENTS

Mr. Spiropoulos spoke to a training he will be doing for the Willow Area Community Organization regarding the Open Meetings Act.

Assemblymember McKee spoke to her pleasure that Resolution Serial No. 22-072 has been adopted.

Assemblymember Hale noted that while he has been out campaigning, the most common complaint he hears from constituents is their distrust in voting machines. Noted that he has voted on them his entire life. Spoke to the need for checks and balances by doing the machine and hand count together. Stated that doing so will ensure that the machines are accurate and that the Borough's election is fair.

Ms. McKechnie responded to public testimony about election officials covering the "Dominion" sign on the side of voting machines during the August election and to comments about ballots having serial numbers. Advised that the election in August was the State's election. Further advised that ballots do not have serial numbers, but the ballot stubs do for ballot accountability. Stated that if they did, it would take away the anonymity of voting.

Assemblymember Yundt spoke to the possibility of having split shifts if ballots are ever counted at precincts. Stated that he would like to see a hand count done before the machine count. Stated that if the annual contract with Dominion had not already been paid, that he would have voted to eliminate the use of voting machines for the 2022 election. Opined that machines will have errors no matter what. Spoke in support of going to hand count only for future elections to make voters feel more secure.

Assemblymember Nowers thanked Ms. McKechnie for clarifying the question on serial numbers on ballots. Stated that she is concerned with the hand count issue because the Canvass Board has expressed that they will no longer work if elections go to hand count at the precincts. Noted the need to have a larger discussion at a more appropriate time. Spoke to having attended the groundbreaking ceremony for the 7th Summit Shooting Range, which is the educational range near Redington High School. Spoke to having participated in the recent fire and rescue training that was put on by the Borough's Emergency Services Department at Station 6-2. Noted that she has a greater appreciation of what fire first responders do physically and mentally. Commented that the legislation for the C-PACE program will be before the Assembly at the next meeting.

Assemblymember Sumner stated that he is sorry he missed the fire and

rescue training as he would have enjoyed it. Agreed with Assemblymember Nowers that if eletions are going to be redesigned that it needs to be a larger discussion at a more appropriate time, not six weeks before an election. Spoke to the need to be conscience of how the Assembly approaches making election changes.

Assemblymember Bernier asked everyone to pray for the Borough. Requested that Mayor DeVries do a proclamation in recognition of a prayer day in the Borough.

Mayor DeVries spoke to attending the groundbreaking ceremony for the improvements to Knik Goose Bay Road. Noted that on September 26th at noon, the Borough will be hosting the Arctic Winter Games International Committee. Requested that some Assembly Members plan to attend and to let her know if they are interested.
