A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY APPROVING THE SCOPE OF WORK AND BUDGET FOR COMMUNITY TRANSPORTATION NONFEDERAL MATCH; MAT-SU CENTRAL SCHOOL CONSTRUCTION; BRETT MEMORIAL ROOF REPLACEMENT; WILDFIRE MITIGATION; AND EMERGENCY MEDICAL SERVICES STATION 12-9.

WHEREAS, the intent and rational of this resolution are found in the accompanying Informational Memorandum No. 22-189 and Ordinance Serial No. 22-101.

NOW, THEREFORE, BE IT RESOLVED that the Matanuska-Susitna Borough Assembly hereby approves the scopes of work and budgets for Community Transportation Non-Federal Match, Mat-Su Central School Construction, Brett Memorial Roof Replacement, Wildfire Mitigation, and EMS Station 12-9.

SCOPE OF WORK

State of Alaska Debt Services Reimbursement funding will be used for Assembly priority projects and grant match as follows:

35473 Community Transportation Non-Federal Match

The Borough is the recipient of Federal grants. These grants traditionally, require the borough provide a cash match. This funding is being set aside to allow the borough to meet the match requirements of these grants.

40205 Mat-Su Central School Construction

This funding will be utilized to fund construction of Mat-Su Central School.

15053 Brett Memorial Roof Replacement

This funding is to allow for the replacement of the Brett Memorial Ice Arena roof.

47109 Wildfire Mitigation (Project name change from Timber Sale Survey)

The borough has been awarded a Bureau of Land Management grant to cover the cost the Saw Crew. This grant requires a match.

10191 EMS Station 12-9

This funding will be utilized for design, construction and related costs of this EMS facility.
