**SUMMARY STATEMENT:**

The Arctic Winter Games will be held in the Matanuska-Susitna Borough in March of 2024. The Games will utilize the Brett Memorial Ice Arena, Government Peak Recreation Area Trails and Borough Gym. The Borough Assembly has the authority to waive and reduce fees to support the Arctic Winter Games at their discretion.

The cost of the Brett Memorial Ice Arena is \$35,655.00 for the week, the gym rental would be \$2,520.00 for the hours needed, the use of the trails at GPRR would be \$1,500 for the week plus parking fees and filming permits are \$500/day per venue. Total costs to be waived

is \$50,175.00.
