**SUMMARY STATEMENT:** On March 15, 2022, the Assembly authorized the award of contract no. 22-054B, Belair Estates Road Improvement Project to Western Construction and Equipment, LLC. The contract expiration date is November 30, 2022.

The project has been delayed due to a greater than average effort required for utility relocations. This extension will allow utilities to be relocated this year and the contractor to complete road construction in the 2023 construction season. The

Administration requests approval of Substantial and Final Completion date extensions for contract no. 22-054B, to August 15, 2023, and December 15, 2023.
