SUMMARY STATEMENT: The Clerk included an increase for the Board of Adjustment and Appeals in her budget, which was approved and adopted by the Assembly. The increase was from \$50 to \$100, which matches the increase received by the Planning Commission and Platting Board.

In early 2021, the Commission on Salaries and Emoluments met and recommended increases to the Planning Commission and the Platting Board compensation.

On December 7, 2021, Assemblymember Sumner sponsored Ordinance Serial No. 21-112, which increased the Planning Commission and Platting Board compensation from \$50 to \$100, based on the recommendation of the Commission on Salaries and Emoluments. This legislation was adopted by the Assembly without objection.

The Board of Adjustment and Appeals compensation review is not under the purview of the Commission on Salaries and Emoluments.

They have not had an increase in their compensation since 1994.

The Board of Adjustment and Appeals hears and decides appeals of decisions of:

- the Planning Commission;
- the Platting Board;
- administrative decisions of the Planning and Land Use Director; and
- appeals from decisions of the Manager made pursuant to MSB 8.50.

The decisions of this highly specialized Board are appealable directly to the Superior Court.

RECOMMENDATION OF ADMINISTRATION: Adoption of the legislation.
