#### VII. MAYOR, ASSEMBLY, AND STAFF COMMENT

School Board Member Trimmer thanked the body for the meeting. Spoke to the value of the School District to the community. Opined that it is important to the community to retain quality educational opportunities. Spoke in support of putting a sales tax before the voters.

School Board Member Retherford noted that School Board Resolution No. 17-02 is preliminary. Stated that it may be discovered that some needs have already been met. Spoke to her appreciation of the cooperative nature of the joint body. Stated that education is one of the most important things the body addresses. Spoke to the need for the joint body to work together to address the current fiscal issues. Spoke in support of full funding of the School District's budget. Spoke to how growth impacts the educational system.

School Board Member Larson noted his agreement that the working relationship of the joint body is solid. Spoke to the need to figure out a way to address the budget deficit. Spoke in support of putting sales tax before voters. Spoke to the possibility of the cities being more involved in funding school budgets. Noted the need for community involvement. Spoke in support of the joint effort of speaking to the State Legislators. Spoke in support of the Borough Area School Site Selection Committee. Spoke to ways that education impacts incarceration.

School Board Member Michaelson spoke in support of the body working together to address budget concerns. Spoke to the possibility of scheduling more joint meetings. Opined that the public supports funding education. Spoke in support of the working relationship of the joint body.

School Board President Dearman stated that she is pleased that the body is working together to address budget concerns. Spoke in support of education. Spoke in support of the working relationship of the joint body. Read an email that she received in which it stated that "school bond indebtedness belongs to municipalities and not the school districts."

Assemblymember Sykes spoke in support of education. Noted that the Assembly and the School District had made a prior commitment to send out a flyer with a joint position on school funding.

Assemblymember Kowalke thanked the body for the meeting. Noted it will be difficult budget cycle this year.

Assemblymember Mayfield noted his support of education. Spoke to concerns with the per student ratio that was presented this evening. Spoke to the coming budget work that the Assembly will be doing.

Assemblymember Colligan thanked the body for the meeting. Spoke to his appreciation of the School District's presentation. Spoke to the need to use common sense moving forward.

Assemblymember Doty stated that she appreciates the leadership of the School District. Spoke to the need to look at future funding.

Assemblymember Beck thanked the School District for the budget presentation. Spoke to his appreciation of his family's positive educational experience with the School District. Spoke to the federal funding based on the military that Fairbanks and Anchorage receive. Noted other districts that have sales tax. Spoke to the need to fund education.

Mayor Halter spoke to recent meeting with the Governor he had, in which he conveyed the message that the Borough could not absorb any more of the bonded indebtedness. Noted how the State pulling back on their share of the indebtedness impacts the Borough. Opined that if a sales tax question goes before voters that it would have to be very clear so that the voters are educated as to the intent.

Assemblymember McKee: Noted his position on his votes for the trapping legislation. Spoke to concerns that the legislation should have come back in whole with a map that delineated the prohibited areas. Spoke to concerns with access to Machetanz Elementary School being so expensive to fix.

Assemblymember Sykes: Noted the expense of fixing access to Machetanz. Thanked the body for the discussion with the School District. Spoke to concerns with funding for the budget. Spoke to the history of working on the trapping legislation. Thanked the public for their testimony. Thanked the body for their amendments.

Assemblymember Kowalke: Opined that a map should have been included in the trapping legislation. Spoke in favor of a clean amendment process with written amendments. Spoke to his attendance at the State Board of Fisheries meeting.

Assemblymember Mayfield: Spoke in support of the trapping legislation as amended. Opined that there was good discussion with public input. Summarized his history of being involved in the trapping legislation.

MOTION: Assemblymember Beck moved to suspend the rules to extend the meeting past 10 p.m. and not to exceed 10:15 p.m.

VOTE: The motion passed without objection.

Assemblymember Doty: Spoke to her appreciation of the public testimony regarding trapping. Opined that it is good for the trapping community to have clear boundaries.

Assemblymember Colligan: Spoke in support of discussion that occurred this evening. Spoke to his concerns with the trapping legislation.

Assemblymember Beck: Opined that trappers will abide by the boundaries set by the Assembly. Spoke to the Trapper Association discussion to put signage at Crevasse Moraine. Noted that public testimony related that it is not professional trappers causing issues.

MOTION: Assemblymember Beck moved to direct the Manager to work with the School District to determine the number of students who are in military homes with children that are in the school district.

VOTE: The motion passed without objection.

Mayor Halter: Noted that the trapping legislation probably should have been adopted sooner. Stated that he knows many trappers and has good relationships with many. Sated that it is better to have total ban rather than set back. Noted that funding for the School District budget will be difficult.

Stated that if a sales tax legislation is brought forward, that it better be clear. Thanked the public for their testimony on the trapping legislation.

Ms. McKechnie spoke to legislation deadlines for ballot items.
