SUMMARY STATEMENT: On February 1, 2017, the Matanuska-Susitna Borough issued a solicitation requesting proposals from qualified Architecture & Engineering firms to design upgrades to the Palmer and Wasilla Pools. The Palmer and Wasilla Pools are both over thirty years old and in need of major renovations to all systems within both facilities. The project includes a renovated lap swim pool for both the Palmer and Wasilla Pools to accommodate competitive activities, the project includes leisure pool to meet the needs of individual recreational users and families.

Additionally, both pools currently share multiple systems with the adjacent high schools, such as mechanical, electrical, plumbing, fire alarms and security. This project will separate these systems to the extent practicable from the adjacent high schools so each pool is a standalone facility. Through the course of design, the utilities for both pools will be separated from the adjacent high schools and metered independently.

In response to the advertisement, two (2) proposals were received and scored. The Award recommendation is being made to Architects Alaska.

Design documents are scheduled to be complete no later than 12/1/17 and will be advertised for competitive bids in January 2018 for the Wasilla Pool and January 2019 for the Palmer Pool.
