MATANUSKA-SUSITNA BOROUGH ORDINANCE SERIAL NO. 17-080

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ACCEPTING AND APPROVING AN APPROPRIATION OF \$12,682 FROM THE INSURANCE PROCEEDS ACCOUNT, FUND 100, AND APPROVING A REAPPROPRIATION OF \$41,000 FROM THE EMERGENCY SERVICES ADMINISTRATION FISCAL YEAR 2017 OPERATING BUDGET TO PROJECT NO. 45257-1803, TO ALLOW FOR THE REPLACEMENT OF AN EMERGENCY SERVICES ADMINISTRATION VEHICLE THAT WAS DESTROYED IN A COLLISION.

WHEREAS, on February 2, 2017, an Emergency Services Administration Command Vehicle (2008 Ford Expedition, License Plate #XYB141) was involved in a collision and determined to be a total loss; and

WHEREAS, the loss of this vehicle has made it difficult for the Fire Deputy Director to conduct official business and requires the juggling of vehicles throughout the department; and

WHEREAS, the replacement of this vehicle will enable the division to operate more efficiently and eliminate the need to borrow vehicles from other areas in the department; and

WHEREAS, the insurance payoff for the destroyed vehicle amounted to \$12,682 and the funds have been deposited into the Borough's Areawide Insurance Claims account, fund 100; and

WHEREAS, the Fire Deputy Director has requested that the insurance funding awarded for the destroyed vehicle be

appropriated to project no. 45257, for the purchase of a replacement Emergency Services Administration command vehicle; and

WHEREAS, the insurance proceeds are insufficient to replace this vehicle and as such, we are also requesting a reappropriation of \$41,000 from the Emergency Services Administration Fiscal Year 2017 Operating Budget to project no. 45257.

BE IT ENACTED:

Section 1. <u>Classification</u>. This ordinance is a non-code ordinance.

Section 2. Acceptance and appropriation source. The Matanuska-Susitna Borough Assembly hereby accepts insurance proceeds in the amount of \$12,682 to fund 100, and approves an appropriation of \$12,682 from the Insurance Claims Proceeds account, fund 100, and approves a reappropriation of \$41,000 from the Emergency Services Administration Fiscal Year 2017 Operating Budget, fund 100, to project no. 45257-1803, fund 425, to allow for the replacement of an Emergency Services Administration vehicle that was destroyed in a collision.

Section 3. <u>Effective date</u>. This ordinance shall take effect upon adoption.
