**MATANUSKA-SUSITNA BOROUGH  
ORDINANCE SERIAL NO. 18-011**

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ACCEPTING AND APPROPRIATING ADDITIONAL FUNDS FOR REVISION NO. 3 IN THE AMOUNT OF \$300,000 FROM THE UNITED STATES FISH AND WILDLIFE SERVICE TO FUND 410, PROJECT NO. 30114, FOR UP TO TWENTY-THREE CULVERT REPLACEMENTS AS PART OF THE FISH PASSAGE IMPROVEMENTS PROJECT, PROJECT NO. 30114

WHEREAS, with the adoption of Ordinance Serial No. 16-004, the Assembly accepted and appropriated grant funds from the United States Fish and Wildlife Service in the amount of \$151,000 to replace up to 23 fish passage culverts; and

WHEREAS, Borough matched funds in the amount of \$106,000 were approved and appropriated; and

WHEREAS, with the adoption of Ordinance Serial No. 16-059, the Assembly accepted and appropriated Revision No. 1 funds from the United States Fish and Wildlife Service in the amount of \$495,000 to replace up to 23 fish passage culverts; and

WHEREAS, Borough matched funds in the amount of \$234,000 were approved and appropriated; and

WHEREAS, with the adoption of Ordinance Serial No. 17-065, the Assembly accepted and appropriated Revision No. 2 funds from the United States Fish and Wildlife Service in

the amount of \$300,000 to replace up to 23 fish passage culverts; and

WHEREAS, Borough matched funds in the amount of \$300,000 were approved and appropriated; and

WHEREAS, on February 20, 2018, the Borough was notified that United States Fish and Wildlife Service has issued Revision No. 3 awarding additional funding in the amount of \$300,000 to replace up to 23 fish passage culverts; and

WHEREAS, the additional funding requires a Borough contribution in the amount of \$300,000; and

WHEREAS, the Assembly has set aside \$600,000 in areawide funds as a part of the fiscal year 2012 capital budget for the purpose of matching grants and \$165,954 remains available; and

WHEREAS, the Assembly has set aside \$250,000 in areawide funds as a part of the fiscal year 2013 capital budget for the purpose of matching grants and \$81,949 remains available; and

WHEREAS, the Assembly has set aside \$250,000 in areawide funds as a part of the fiscal year 2015 capital budget for the purpose of matching grants and \$26,558.15 remains available; and

WHEREAS, the Assembly has set aside \$190,000 in areawide funds as a part of the fiscal year 2016 capital budget for the purpose of matching grants and \$190,000 remains available; and

WHEREAS, the Operations and Maintenance Division would like to identify \$300,000 of these funds as match for this project; and

WHEREAS, no expenditures can be made until a scope of work and budget has been approved by the Assembly.

BE IT ENACTED:

Section 1. Classification. This ordinance is a non-code ordinance.

Section 2. Acceptance and appropriation source. There is hereby accepted and appropriated by the Matanuska-Susitna Borough Assembly, Revision No. 3, additional funding in the amount of \$300,000 from the United States Fish and Wildlife Service, to fund 410, project no. 30114, for up to 23 culvert replacement as part of the Fish Passage Culvert Replacement Project.

Section 3. Effective date. This ordinance shall take effect upon adoption.


