**MATANUSKA-SUSITNA BOROUGH
ORDINANCE SERIAL NO. 19-011**

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ACCEPTING AND APPROPRIATING \$646,500 FROM THE UNITED STATES FISH AND WILDLIFE SERVICE, PASSED THROUGH THE ALASKA STATE DEPARTMENT OF FISH AND GAME; AND REAPPROPRIATING \$37,794.15 FROM THE FISCAL YEAR 2016 GRANT MATCH; \$150,000.00 FROM THE FISCAL YEAR 2017 GRANT MATCH; AND \$27,705.85 FROM THE FISCAL YEAR 2018 AREAWIDE CAPITAL APPROPRIATION FOR GRANT MATCH TO FUND 440, PROJECT NO. 15019.

WHEREAS, Lake Louise is an important waterbody within the Matanuska-Susitna Borough; and

WHEREAS, changes in the lake level, normal wear and tear, and increased recreational use has degraded the boat ramp and created the need to improve the parking area; and

WHEREAS, the Borough has been notified of a grant award in the amount of \$646,500 from the United States Fish and Wildlife Service, passed through the Alaska State Department of Fish and Game, for the Lake Louise Recreation Site Upgrades; and

WHEREAS, the grant requires a Borough match in the amount of \$215,500; and

WHEREAS, in the fiscal year 2016 capital projects budget, the Assembly appropriated \$190,000 in areawide funds for grant matches to fund 480; and

WHEREAS, it is our intention to use \$37,794.15 of this funding towards the required match for the Lake Louise upgrades grant; and

WHEREAS, in the fiscal year 2017 capital projects budget, the Assembly appropriated \$150,000 in areawide funds for grant matches to fund 480; and

WHEREAS, it is our intention to use \$150,000 of this funding to fulfill the required match for the Lake Louise upgrades grant; and

WHEREAS, in the fiscal year 2018 capital projects budget, the Assembly appropriated \$200,000 in areawide funds for grant matches to fund 480; and

WHEREAS, it is our intention to use \$27,705.85 of this funding to fulfill the required match for the Lake Louise upgrades grant; and

WHEREAS, the Assembly must pass an ordinance to formally accept and appropriate the grant funds and reappropriate the grant match funds from fund 480, to fund 440.

BE IT ENACTED:

Section 1. Classification. This Ordinance is a noncode ordinance.


Section 2. Acceptance and Appropriation Source. The Assembly does hereby accept and appropriate grant funds in the amount of \$646,500 from the United States Fish and Wildlife Service, passed through the Alaska State Department of Fish and

Game to fund 440, project no. 15019, for the Lake Louise Recreation Site Upgrades.

Section 3. Reappropriation Source. The Assembly does hereby reappropriate funds from the fiscal year 2016 areawide capital appropriation for grant match in the amount of \$37,794.15; \$150,000 from the fiscal year 2017 areawide capital appropriation for grant match; and \$27,705.85 from the fiscal year 2018 areawide capital appropriation for grant match from fund 480, to fund 440, project no. 15019.

Section 4. Effective Date. This ordinance shall take effect upon adoption.
