SUMMARY STATEMENT:

The Mat-Su Borough currently conducts absentee in-person voting starting 15 days prior to the election. These absentee in-person ballots are then canvassed by the Canvass Board, and at times are not finalized or counted until the day before the election certification. Absentee voting numbers continue to rise and with contentious propositions on the ballot the volume has been very high. The year the marijuana proposition was placed on the ballot, the Canvass Board worked some 15-hour days through the week and the weekends. Luckily we were able to finish in time for the deadline to certify the election. With these trends, the Clerk's Office has had to think of new ways to move forward, with integrity of our election process in mind.

The Clerk is working towards starting an early voting process, which MSB code already allows for. The benefits to early voting rather than absentee voting is that those early voting ballots cast are counted the night of the election and will reduce the number of ballots the Canvass Board needs to canvass after the

election. This means that more votes are calculated on election night and the Canvass Board can complete their process sooner.

Differences between early voting and absentee in-person voting:

Early voting:

- o is like walking into your polling location on election day. Your identity is verified by an election official, you sign the register, receive and cast a ballot, with the results of the votes announced election night.
- o early voters will go through the same process as they do at their polling location, but will also sign an oath that they still reside at their registered address and will not vote in any other manner in the election.
- o if the voter's residence address has changed, they will be required to vote a question ballot.

• Absentee in-person voting:

- o the voter's identity is verified by an election official, the voter completes an absentee oath an affidavit envelope and the voter receives and casts a ballot. After election day the Canvass Board canvasses all of these and they are looking at: did the voter change their residence address, did they qualify for the ballot they received, were they registered in the Borough, etc.
- o results of absentee in-person voting are not announced election night, but after the Canvass Board finishes their canvassing and the Review Board comes in to count the ballots.

Prior to 2019, the MSB has not offered early voting, as the precinct registers are printed by the State of Alaska, Division of Elections (DOE). We do not have access to the live voter registration database like the State does during their early voting. In State elections, as people early vote it shows up on their voter registration record and when the precinct registers are printed it states in the signature line "Voted Early." Meaning that voter's will then not be able to go to their precincts and vote again on election day. The MSB has proposed to the DOE that we print our own precinct registers, which the DOE has agreed to.

The MSB already receives a digital record of the voter's within the MSB. We already export the digital information into a database, which we use for absentee in-person voting. We would take this a step further and use it for early voting and then to print out our registers for the precincts. We will have to stop early voting prior to election day, so that the precinct registers can be printed with the "Voted Early" in the voters signature lines and then be provided to the precinct chairs. Once early voting has

ended, absentee in-person voting would occur for the remainder of the voting period.

I expect that early voting will last through the Saturday prior to the election, but we are still working through the process. Please see below for the anticipated times and locations of early voting, by-mail voting, and absentee in-person voting.

- By-mail voting conducted as usual
- Borough Building Palmer open Monday through Friday
 - o Early voting Monday 10/21 Friday 11/1
 - o Absentee in-person Monday 11/4 Tuesday 11/5
- Division of Election Wasilla open Monday through Saturday
 - o Early voting Monday 10/21 Saturday 11/2
 - o Absentee in-person Monday 11/1 (closed election day)
- Absentee in-person voting will also occur at the city of Houston, Talkeetna Library, and Trapper Creek Library, during their operating hours - Monday 10/21 - Monday 11/4 (closed election day).

Please see attached examples of the oath that the early voters will sign and an example on how the early voters will appear on the precinct registers.
