## MATANUSKA-SUSITNA BOROUGH ORDINANCE SERIAL NO. 19-035

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ACCEPTING AND APPROPRIATING \$50,000 FROM THE GREAT LAND TRUST TO FUND 440, PROJECT NO. 15040, TO DEVELOP THE SETTLERS BAY COASTAL PARK (MSB007387).

WHEREAS, the Matanuska-Susitna Borough received property from the Great Land Trust identified as the Settlers Bay Coastal Park, which abuts the Knik Arm in the Settlers Bay and Secluded Point subdivisions; and

WHEREAS, the Matanuska-Susitna Borough Assembly adopted Ordinance Serial No. 18-050, adopting the Settlers Bay Coastal Park Recreation Development Plan, June 19, 2018; and

WHEREAS, the Borough Community Development Department has partnered with Great Land Trust on a Mat-Su Trail and Park Foundation grant application for development of the park; and

WHEREAS, the Mat-Su Trail and Park Foundation approved the application and awarded Grant #2018-402 in the amount of \$100,000 to the Borough; and

WHEREAS, the Assembly adopted Ordinance 18-106 on December 18, 2018, that accepted \$100,000 in grant funds from the Trails and Parks Foundation; and

WHEREAS, the grant requires a match of \$100,000, which will be provided by a \$50,000 cash contribution from the Great Land Trust and in-kind contributions from the Borough; and

WHEREAS, the Great Land Trust will provide a cash match of \$50,000 through direct purchase of goods and services for the project; and

WHEREAS, the Borough will provide \$50,000 of in-kind match by the Land and Resources Management Division and the Borough Recreation Services Division 2019 operating budget for staff time working on the project, and use of existing recreation services equipment such as the bobcat, ATVs, and a mini-excavator; and

WHEREAS, funding and in-kind services committed after the date of the grant award letter may be counted as match in accordance with guidance from the Executive Director of the Mat-Su Trail and Park Foundation.

## BE IT ENACTED:

Section 1. <u>Classification</u>. This Ordinance is a noncode ordinance.

Section 2. <u>Acceptance</u>. The Assembly hereby accepts \$50,000 from the Great Land Trust for development of the Settlers Bay Coastal Park.

Section 3. Appropriation Source. There is hereby appropriated by the Assembly \$50,000 from the Great Land Trust, to project no. 15040, fund 440, for development of the Settler Bay Coastal Park.

Section 4. <u>Effective Date</u>. This ordinance shall take effect upon adoption.
