MATANUSKA-SUSITNA BOROUGH ORDINANCE SERIAL NO. 19-030

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ESTABLISHING A BOROUGH TASK FORCE TO INVESTIGATE AND CONSIDER STEPS TO DEVELOP A PROPOSAL TO VOTERS THAT ADDS SPECIFIC POLICE POWERS TO ITS RESPONSIBILITIES.

WHEREAS, the voters of the Borough voted to have the Borough staff investigate and consider steps to develop a proposal to voters that adds police powers to its responsibilities; and

WHEREAS, the Assembly directed the Manager, at the Assembly Planning Work Session on January 19, 2019, to form a task force to fulfill the voters request; and

WHEREAS, a series of public meetings and a public survey in 2018 determined that citizens consider crime in the Borough to be a serious problem; and

WHEREAS, the citizens want something done about crime in the Borough; and

WHEREAS, there is a need for people knowledgeable of possible police powers options to provide recommendations; and

WHEREAS, in order to expedite the creation of this task force this noncode ordinance is being utilized in lieu of the normal nomination and vacancy process.

BE IT ENACTED:

Section 1. Classification. This is a noncode ordinance.

Section 2. <u>Effective date</u>. This ordinance shall take effect upon adoption.

Section 3. Formation of a Police Powers Task Force. The Deputy Borough Manager, George Hays, will be the chairperson and will facilitate the meetings of the Police Powers Task Force. In the event of a tie vote, the Deputy Manager may cast a tiebreaker vote, but will otherwise not be a regular voting member. The task force will consist of 10 full-voting members; the Deputy Manager only votes in case of a tie, and three ex officio non-voting members who will be nominated by the Mayor and confirmed by the Assembly as follows:

Section 4: <u>Purpose of the Task Force</u>. The Police Powers Task Force will investigate and consider steps to develop from one to three prioritized, fiscally reasonable, and possible proposals for the purpose of sending them to the Assembly for consideration. The Assembly will consider whether to present one or more of these proposals to the voters on the next regular ballot for the purpose of adding specific police powers to the Borough's responsibilities.

Section 5: This Police Powers Task Force shall have their recommendation to the Assembly on, or before, June 28, 2019, and shall sunset on December 31, 2019.
